

**MINOR LIABILITY WAIVER, RELEASE OF CLAIMS
AND ASSUMPTION OF THE RISK**

I, _____, am the parent or legal guardian of the minor student, _____ (hereinafter "Student"). On Student's behalf I hereby request that Student be allowed to attend and participate in an event, _____ ("the Event"), sponsored by National Association for Campus Activities ("NACA").

In my role as parent/legal guardian, I recognize that Student's participation, involvement and/or attendance at any NACA event or the Event is voluntary and may result in physical injury (including death) and/or mental injury. By agreeing to Student's attendance, observation and/or participation in the Event, I, on behalf of Student and myself, acknowledge and assume all risks and dangers associated with Student's observation, participation and/or attendance at the Event

I understand that Student will have the opportunity to attend and participate in a myriad of programs and activities. I understand these activities may include, but are not limited to, attending showcases, and meeting and interacting with artists and other attendees who may be significantly older than Student. I understand that Student may elect to participate in events that feature or include demonstrations that would involve Student physically, through use of equipment or the wearing of devices or apparel provided by an exhibitor or performer such that there exists a potential risk of physical harm to Student. I understand that neither NACA nor any of its employees or agents will supervise or be responsible for Student in any way at any time. I understand that NACA is not obligated to allow Student to attend and that the only reason it is willing to do so is the fact I am executing this Waiver and Release on Student's behalf.

Assumption Of Risk

I hereby give my express permission for Student to attend and participate in the Event as Student chooses.

I knowingly, on behalf of myself, Student, our respective heirs, devisees, assigns, and any other person or entity claiming by or through either of us, do hereby freely assume all risks related to Student attending the Event, even if the risk arises from the negligence or fault of the Released Parties (as defined below).

I knowingly, on behalf of myself, Student, our respective heirs, devisees, assigns, and any other person or entity claiming by or through either of us, assume the risk of injury, harm and loss associated with the Event, including any injury, harm and loss caused by the negligence, fault or conduct of any kind on the part of the Released Parties (as defined below).

Waiver And Release

IN CONSIDERATION OF NACA PERMITTING MY STUDENT TO ATTEND THE

EVENT, AND PARTICIPATE IN THE ACTIVITIES THEREIN, I, ON BEHALF OF MYSELF, STUDENT, OUR RESPECTIVE HEIRS, DEVISEES, ASSIGNS, AND ANY OTHER PERSON OR ENTITY CLAIMING BY OR THROUGH EITHER OF US, HEREBY RELEASE, WAIVE AND FOREVER DISCHARGE ANY AND ALL LIABILITY, CLAIMS, AND DEMANDS OF WHATEVER KIND OR NATURE AGAINST NATIONAL ASSOCIATION FOR CAMPUS ACTIVITIES AND OR RELATED ENTITIES INCLUDING ITS BOARD OF DIRECTORS, EMPLOYEES, VOLUNTEERS, STUDENTS, AND ANYONE ELSE ASSOCIATED WITH NACA AND THEIR SUCCESSORS AND ASSIGNS (COLLECTIVELY, "RELEASED PARTIES"), EITHER IN LAW OR IN EQUITY, INCLUDING BUT NOT LIMITED TO DAMAGES OR LOSSES CAUSED BY THE NEGLIGENCE, FAULT OR CONDUCT OF ANY KIND ON THE PART OF THE RELEASED PARTIES. THIS WAIVER AND RELEASE INCLUDES BUT IS NOT LIMITED TO DEATH, BODILY INJURY, ILLNESS, ECONOMIC LOSS OR OUT OF POCKET EXPENSES. I UNDERSTAND AND AGREE THIS WAIVER AND RELEASE IS BINDING ON MY HEIRS AND THOSE OF STUDENT, ASSIGNEES, NEXT OF KIN AND/OR LEGALLY APPOINTED OR DESIGNATED REPRESENTATIVES AND IS INTENDED TO APPLY TO AND INCLUDE ANY CLAIM(S) THAT MAY HEREINAFTER ACCRUE OR ARISE FROM MY PARTICIPATION IN THE EVENT. I AGREE AND INTEND THAT THIS RELEASE AND WAIVER IS TO INTERPRETED TO PROVIDE A FULL RELEASE OF LIABILITY TO THE FULLEST EXTENT PERMITTED BY LAW AND WAIVE ANY CLAIM THAT I MAY HAVE.

I also agree to hold harmless Released Parties for any damage or loss I or Student may incur as a result of Student's participation and attendance at the Event. I also agree to release and hold harmless Released Parties for any loss or injury Student may incur directly or indirectly related to the use of any means of transportation, service, restaurant, or other firm, agency, company or individual as a result of Student's participation at the Event.

I agree that NACA shall have the discretion and right to enforce appropriate standards of conduct for any person at the Event and that NACA and its employees or representatives may at any time, within their own discretion, limit or terminate Student's participation in Event for failure to maintain these standards. I further understand that, for severe misconduct, Student may be expelled and asked to leave the Event, and I understand that NACA will not bear the travel costs associated with Student returning home.

In the event of a medical emergency, I grant NACA, its agents and representatives, full authorization to take such action as reasonably necessary or appropriate to protect Student's health and safety, including, at the discretion of NACA, its agents and representatives, and at my expense, arranging for emergency transportation to the nearest medical facility, if necessary, and placing Student under the care of medical professionals at such place for medical examination and/or treatment or for further transportation to the appropriate treatment facility as considered medically necessary or advisable after consultation with the applicable medical authorities. I understand that no guarantees have been made by NACA as to the effect of any such treatment Student may

receive at any such facility, and I acknowledge and accept financial responsibility for all charges in connection with the transport, care, and treatment given in such a situation.

I further understand and agree that NACA, at its sole discretion, may take, process, publish, and/or otherwise use photographs of any Student while participating in the event, in any way deemed appropriate by NACA. I hereby grant NACA full permission and consent to so take, use, process, and publish such photographs.

I have read the terms and conditions set forth herein. I understand that if I have questions regarding any of the terms or conditions of this Release and Waiver, I should contact an attorney of my own choosing before executing this document. I have read the above statements and understand and agree to the terms set forth herein. I have read the terms and conditions and understand that they constitute a part of my agreement with NACA. I certify that I am not under any coercion or duress to execute this Minor Liability Waiver, Release Of Claims And Assumption Of The Risk. In signing this Minor Liability Waiver, Release Of Claims And Assumption Of The Risk, each of the undersigned acknowledge and warrant that they have carefully read this document, that they understand its terms, and that they sign it freely and voluntarily.
